We know you are all anxiously awaiting information about the Covid-19 vaccine. What we know is that Walgreens is our contracted vaccinator. Walgreens has informed us they will administer the Moderna vaccine to both residents and staff tentatively the WEEK of December 28th. If this changes we will let you know.

Consent forms will need to be signed by all residents and staff prior to vaccination. If the resident has given up Guardianship or been deemed incompetent, we ask that the legal guardian sign the consent form.

If you are the power of attorney and would not like your loved one to receive the vaccine, please call Tim Blattel at Twin Oaks to discuss 636-542-5202. We want to make sure all concerns are addressed if possible.

Once the first dose of vaccine is administered, the second dose would typically be given within 28 days. They should have achieved immunity within 14 days of second dose.

We will be in contact with the Department of Health and Senior Services as well as the St. Charles County Health Department to release the residents for visitation after immunity is achieved.

This is such an answer to our prayer. Everyone has been so patient and supportive of our efforts to keep the residents safe. Staff has been amazing and taken enormous life changing steps to stay safe and tell us at the first sign of sickness or proximity of a COVID-19 positive person. We are so humbled by all involved and feel very blessed that all are still healthy. We thank you all. Now we need your help and patience to get to the finish line. Please adhere to the same protocols and guidelines you have been doing until we complete both vaccinations and have been released from the Department of Health and Senior Services. Any outbreak could alter our vaccination schedule. This means Christmas will have to follow the same protocols we observed at Thanksgiving. Visitation will have to be in the visitation rooms or outside at designated areas.

We will be in close communication and look forward to the day when we see you embracing your loved ones again.

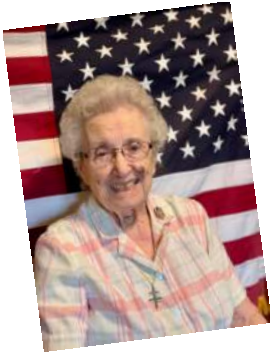
